  - **relevant skills - analytical skills** (eg. ability to critically evaluate data, reports, and policies; strong problem-solving and decision-making skills) and **communication skills** (eg. proficiency in writing clear, concise and objective feedback in English (fluent in oral and written communication – min. B2); effective verbal communication for discussions with institutional representatives)
  - **independence and ethical standards** - no direct or indirect affiliation with the institution under review, commitment to impartiality and avoiding conflicts of interest, adherence to professional and ethical guidelines, ensuring confidentiality and objectivity throughout the review process
  - **sufficient availability** - time commitment to dedicate sufficient time for reviewing the report and participating in discussions or site visits, and preparedness for training - willingness to undergo orientation or training related to the Accreditation framework.


